SherpTek Limited Warranty

SherpTek warrants to the original purchaser ("Owner") of this truck bed system ("Bed") to be free of defects in materials and workmanship, under normal conditions and use, with reasonable care and maintenance, from the date of purchase throughout the "Warranty Period," subject to the exclusions and warranty periods listed below.

WARRANTY PERIODS:

five (5) years:

All materials and parts manufactured by SherpTek. Excludes component parts constructed or assembled by other manufacturers.

one (1) year:

Wiring, electrical, seals, compressor, and fuel system work done by SherpTek. Excludes component parts constructed or assembled by other manufacturers.

ninety (90) days:

Mounting of the Bed to the chassis.

COVERAGE PROVIDED

Within the Warranty Period, SherpTek is obligated to repair or replace any part covered by this warranty proven defective by the Owner.

This is the only warranty given with the purchase of the Bed other than express or implied warranties given by the component manufacturers. Any warranties implied by law are limited to the Warranty Period. Any other warranty, express or implied, not provided for in this Limited Warranty is waived by the Owner.



OWNER'S OBLIGATION

Owner must notify SherpTek of any defect promptly upon discovery, provide proof of purchase and provide proof of defect before SherpTek will issue replacements or repairs. The Owner must contact SherpTek for a service appointment. The cost of transporting the truck and/or Bed to SherpTek shall be incurred and paid for by the Owner. If it is not possible to return to SherpTek, SherpTek will coordinate alternative plans with the Owner, and Owner shall incur and pay charges associated with the repair other than covered parts and labor. Freight charges for replacement items will be incurred by Owner. Warranty repairs or removal of Bed by anyone other than SherpTek must be approved by SherpTek prior to any work being started. Any work done without approval is not covered under this warranty and will void the warranty.

It is the Owner's obligation to know, understand and follow the truck manufacturers Gross Vehicle Weight Rating (GVWR), Gross Axle Weight Rating (GAWR), tire loading and Center of Gravity (GG) guidelines; and to comply with all state and federal laws regarding such.

EXCLUSIONS

The scope of this warranty is expressly limited to only items actually constructed by SherpTek. SherpTek therefore makes no warranty with respect to component parts constructed or assembled by other manufacturers, including, but not limited to, the Liquid Propane Gas (LPG) tanks and appliances, electrical parts, plumbing (air, water, fuel), lights, connectors, fittings, hinges, brackets, airbags, etc. Such component parts may be warranted by their respective manufacturers. SherpTek will assist Owner with necessary third-party product warranty information if needed.

This warranty does not cover damage caused by or related to (1) normal wear and tear, (2) accidents, abuse, misuse or negligence, (3) failure to comply with instructions and loading guidelines contained in the Owner's Manual, (4) any alteration or modification of the Bed, (5) environmental conditions, including, but not limited to, road salt, rock chips, hail or windstorm, (6) failure to comply with SherpTek's recommended inspection and maintenance schedule and procedures, (7)

failure to stay within truck manufacturers Gross Vehicle Weight Rating (GVWR), Gross Axle Weight Rating (GAWR), tire loading, and adherence to Center of Gravity (CG) guidelines, or (8) Act of God.

No payment or other compensation will be made for incidental expenses, including, but not limited to, towing, telephone, transportation, lodging, travel, gasoline, loss of pay or indirect or consequential damage including, but not limited to, loss of use of the truck or Bed, inconvenience, damage or injury to person or property, or loss of revenue, which might be paid, incurred or sustained by reason of manufacturer's defect covered by this warranty.

As the manufacturer of the Bed that you purchased, SherpTek does not know the purpose you have in mind for your truck and Bed. SherpTek has provided updated vehicle and axle weights with the Bed installed. It is the Owner's obligation to know, understand, and follow the truck manufacturers Gross Vehicle Weight Rating (GVWR), Gross Axle Weight Rating (GAWR), tire loading, and Center of Gravity (GG) guidelines; and to comply with all state and federal laws regarding such. Therefore, SherpTek makes no warranties or representations, express or implied, as to the performance of your truck with the Bed, or whether the match-up of your truck and payload exceeds the GVWR as specified by your truck's manufacturer. Specifically, there is no express or implied warranty of merchantability or of fitness for the particular match of your truck to any particular payload (including campers).

Any work done without approval is not covered under this warranty and will void the warranty.

This warranty is non-transferable between owners and trucks.

This Limited Warranty is intended to comply with the requirements of both State and Federal laws. Any part of this Limited Warranty in conflict with any law shall be ineffective to the extent of any such conflict. This warranty gives you specific legal rights, and you may also have other rights, which may vary from state to state.
